The River Keeps Flowing...

Many of us are in clubs or organizations other than the Michigan State Association of Parliamentarians (MSAP). Some of us became members of the National Association of Parliamentarians (NAP) to help function in other groups. Non-parliamentary organizations keep me grounded about how ordinary clubs have meetings as well as providing social and cultural connections.

I'm on the Bylaws Committee in one of my favorite non-parliamentary clubs. We recently reviewed our standing rules.

Unlike rivers that flow and are everchanging, bylaws, and standing rules are static. However, surroundings may alter their applicability. Standing rules (and bylaws) can get outdated. For example, it would be hard to find a funeral floral arrangement for \$30 or a baby gift under \$20. We learned this past year that we can meet virtually. The river flowed, we changed, and we will not return to how it used to be. Standing rules are rules related to the details of administration and can be adopted and changed like any ordinary act of a society.

Have you looked lately at standing rules or policies and procedures or whatever you call them in your clubs?

- Do they include assumptions that are no longer true?
- Are you requiring payment by check for events?
- Are you expecting committees to meet in person?
- Do you insist that notices must go out by United States mail?
- Do you ask for too much personal information from new members?
- Are some practices so old-fashioned that they alienate new members?

The committee reviewed the rules and noted how they did not make sense for this time and place, so we made recommendations for change. But our recommendations are just that, and though we believe that they are better for the club now, the committee's suggestions may not be the will of the club.

The proposals we are recommending will be an impetus for lively discussion, a time for the club once again to clarify who we are and how we want to continue our ordinary practices. We do not step in the same river twice.

NAP Examinations and Credentials

Legacy Registered Parliamentarian Test based on the 11th Edition of RONR

December 31, 2021 is the test's retirement date. You must have passed two test sections, excluding Section 1, by this date to continue with this test instrument for completion and certification.

Registered Parliamentarian

To retain RP status, twenty Continuing Education Credits (CEUs) must be earned within a six-year period, reference https://www.parliamentarians.org/RP%2612thEd.

Counting Days in Compliance with RONR

How do you count the days for notice to vote on bylaw amendments if not prescribed in the local bylaws? RONR 9:4 and 56:34, explains how to count the days. Count all calendar days, including the day the notice is sent, holidays, and weekends, do not count the day of the meeting when voting will occur.

Adjourning a Meeting

There are three instances when a Motion to Adjourn (§21) is a Privileged Motion, instances when meetings can dissolve without a Motion to Adjourn.

- a. When the time arrives to end the meeting that was adopted at the beginning of the meeting or on approval of the Agenda, the Chair announces when the time arrives, and unless someone quickly moves to set aside the Orders of the Day, the Chair can declare the meeting adjourned.
- b. When the Agenda is completed. The Chair may ask if there is any more business and if none comes forward, the Chair declares the meeting adjourned.
- c. When there is an emergency, the Chair can declare the meeting adjourned and announces when and/or where to meet again to conclude the meeting.

Remember, a meeting is not adjourned until the <u>President/Chair/Presiding Officer declares it adjourned</u>. It is not the maker and seconder of the Motion to Adjourn, or those in attendance after a voice-vote, no matter how loud or unanimous.

The Motion to Adjourn takes precedence over all Privileged Motions, except the Motion to Fix the Time to Which to Adjourn. The Motion is out of order when another has the floor, while there is voting, the counting of the votes, or before the voting results is announced, unless voting is by ballot. It is out of order when the ballots are being collected by the Tellers, in order after the collection and before the results are announced.

It yields to applicable Incidental Motions that arises which must be disposed of before the Motionto Adjourn is voted. The Motion to Adjourn:

- **1. Cannot interrupt the speaker who officially has the floor**, (Emphasis added.)
- 2. Must have a second,
- 3. There is no debate,
- 4. Cannot be amended,
- 5. Must have a majority-vote,
- 6. Cannot be reconsidered but can be renewed if business or progress in debate has gone forward after it failed.
